

CONTESTANT ENTRY AFFIDAVIT - MISS DALLAS AND MISS DALLAS TEEN PAGEANT

I hereby apply as an entrant in the CIRCLE ONE: **MISS DALLAS PAGEANT / MISS DALLAS TEEN PAGEANT**
and I acknowledge and agree as follows:

1. (a) MISS: The date of my birth is: _____. I will be at least 18 as of age on January 1, 2027
(b) TEEN: The date of my birth is: _____. I will be at least 14 and under 19 years of age on January 1, 2027

2. If I am a teen, I have never been married nor had a marriage annulled. I have never given birth to a child, I am not a parent, and I am not currently pregnant.

3. I am a female, a citizen of the United States and will remain a citizen of the United States through the State Pageant and, if I win the State Pageant,

4. I satisfy at least one of the two following residency requirements:
(a) I now reside in my local area and have resided in Texas as my permanent and primary residence for a period of at least six consecutive months immediately prior to the commencement of the State Pageant (although I may have attended school, college or university on a full-time basis elsewhere). "Permanent and primary residence" means my true, fixed and permanent domicile which I intend to make my permanent home.
OR,
(b) I have resided in my local area in the state of Texas as a full time student at a school, college or university for one entire semester (excluding summer terms) immediately prior to the commencement of the State Pageant and I continue to reside in the State as a full time student at my school, college or university (although I may have spent or be spending the summer in another State).

5. I am not currently a candidate for public office.

6. I am not a member of a performing arts union or guild.

7. I have not appeared on any television contest, game or reality show in the past year.

8. I represent that at all times prior to the date of this Agreement, I have conducted my activities and life in accordance with the highest ethical and moral standards and that I have never been charged with the commission of a crime or engaged in any activities that might bring myself, you, or the State Pageant, sponsors or any of their respective subsidiaries, affiliated or related companies, officers, directors, partners, shareholders or employees into public disrepute, ridicule, contempt or scandal or might otherwise reflect unfavorably upon any of the foregoing individuals or entities or might shock, insult or offend the community or any class or group thereof. I acknowledge that, by way of example, and without limiting the generality of the foregoing in any way, having appeared in public or permitted myself to be photographed in a state of partial or total nudity, or in a lewd, compromising or sexually suggestive manner constitutes a violation of this subparagraph.
